## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. ### SECTION 5: Firefighting measures

#### 5.1. Extinguishing media
